The Department of Education – Schools Division of Zamboanga City through its Bids and Awards Committee (BAC) invites distributors/suppliers/manufacturers to apply for eligibility and to bid for the hereunder project:

The DepEd – SDO ZC, through the FY 2023 General Appropriations Act intends to apply the sum of Approved Budget for the Contract (ABC) to payments under the contract for the following:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The DepEd – SDO ZC now invites bids for the above Procurement Project. Delivery of the Goods is required by 365 Calendar Days. Bidders should have contracts similar to the Project refer to contracts which have the same major categories of work (i.e. Building Construction)

Pursuant to Section 23.4.2.4 of the 2016 revised IRR of R.A. 9184, a contract shall be considered "similar" to the contract to be bid if it has the same major categories of work. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section III (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Prospective Bidders may obtain further information from DepEd - Division of Zamboanga City and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.

- a. A complete set of Bidding Documents may be acquired by interested Bidders on 1 1 August 2023 from the Bids and Awards Committee Secretariat DepEd Schools Division Office of Zamboanga City upon accomplishing a bidder's information sheet and payment of a non-refundable fee for the Bidding Documents to the DepEd Cashier.
- b. Interested Bidders may signify their intent to purchase the Bidding Documents through email at <a href="mailto:bac.zamboangacity@deped.gov.ph">bac.zamboangacity@deped.gov.ph</a>. Upon receipt of the bidder's intent and information, the BAC Secretariat will send through email the details of the Account for payment. Upon payment, bidders shall send through email the proof of payment before the deadline for submission of bids. Upon receipt of proof of payment, the BAC Secretariat will send the electronic copy of the Bidding Documents of 25,000.00 Pesos for the project.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees.

Considering the current situation due to the pandemic (COVID-19) and the mandate to observe social distancing, DepEd SDO of Zamboanga City will hold a Pre-Bid Conference for this Project on **August 17**, **2023** at CID Conference Room, DepEd SDO of Zamboanga City, Baliwasan Chico, Zamboanga City, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through **Manual Submission** at the office address as indicated below on or before **August 30**, **2023 at 9:00AM**. Late bids shall not be accepted.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

**Bid opening** shall be on **August 30, 2023 at 9:30AM** at DepED – Schools Division Office, Baliwasan Chico, Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

For the purpose of constituting a quorum, both the physical and virtual presence of the BAC and TWG members shall be considered pursuant to GPPB Resolution No. 09-2020.

The DepEd – Division of Zamboanga City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
